






Single-Family Housing Home Purchase Programs

Direct Loans & Loan Guarantees

- No Down Payment Required
- 100% Affordable Fixed Rate Financing
- Can Include Closing Costs and Repairs
- No Private Mortgage Insurance (PMI)
- No Prepayment Penalties
- Subsidized Interest Rate for Eligible Low Income Applicants
- Property Eligibility Criteria & Income Limits Apply



Single-Family Housing Home Repair Programs

- Provides funding for essential home repairs
 - Accessibility Modifications
 - Roofs
 - Wells & Septic Systems
 - Energy Efficiency Improvements & more
- Loans up to \$20,000 at fixed 1% interest rate
- Grants up to \$7,500 for elderly households to correct health or safety issues
- Property Eligibility Criteria & Income Limits Apply




Business & Industry Loan Guarantees

- Convert, enlarge, repair, modernize or develop business
- Purchase and develop land, easements, rights-of-way, buildings or facilities
- Purchase equipment, machinery, supplies or inventory
- Refinance when new jobs will be created and other conditions are met
- Acquire businesses and industries when the loan will keep the business from closing and/or save or create jobs



Rural Energy for America Program (REAP)



Value Added Producer Grant Program (VAPG)

- Conducting feasibility studies
- Developing business plans
- Processing costs
- Marketing and advertising expenses
- Some inventory and salary expenses



Rural Business Development Grant Program (RBDG)

- grants to Public Bodies, Indian Tribes and Qualified Non Profit Organizations for small business assistance (less than 50 employees and \$1 million in revenues), asset purchase, establishment of a revolving loan fund
- provides grant money to assist with economic development planning and/or the financing or expansion of rural business


Water & Environmental Programs

Electric Programs

Loans and grants to rural electric utilities to build, maintain, upgrade and modernize electric power systems.




Telecommunications Programs

Loans and grants to build, maintain, upgrade and modernize high-speed Internet broadband and telephone service in rural areas.



ReConnect Pilot Program


- Expand broadband service to rural areas that do not have sufficient service
- Congress provided Rural Development with \$550 million & expanded its existing authority to make loans & grants
- Reaches rural areas where 90% of households do not have sufficient access to broadband service (defined as 10Mbps downstream & 1 Mbps upstream)



Wisconsin Rural Development Impact

Last year alone, USDA Rural Development helped the residents of Wisconsin by leveraging **more than \$470 million** in funding for economic development projects and quality of life improvements that:

- helped create or retain over 700 jobs;
- aided over 1,900 families in buying or repairing their own homes;
- assisted over 5,900 renters in retaining affordable housing;
- supported 46 rural businesses throughout the state; and
- assisted 20 communities and impacted numerous residents in improving essential community facilities and local infrastructure.
